D. Final declaration

1. **I have given all the information correctly.** I have not intentionally misrepresented anything. I have handed in all the supporting documents that I have. **If the authorities want me to**, I have to have documents that are not in German translated. Then I have to hand in the documents in German.
2. **I have to give an address.** The authority sends all letters to me to this address. If this address changes, I have to notify the authority immediately.
For example, if I move house. If the authorities repeatedly fail to deliver a letter to me, they can discontinue the procedure. Then I don't get a residence permit!

If any of the information on this form changes, I have to report it to the authorities immediately!
I have to do this in writing. I have to send all the important documents.

3. I am not allowed to marry someone just to get a residence title! I am not allowed to arrange a marriage for someone just so that he or she gets a residence title.

I am not allowed to adopt someone just so that he or she gets a residence title. No one is allowed to adopt me just so that I can get a residence permit. I am not allowed to arrange an adoption just so that she or he gets a residence title.

These marriages and adoptions are punishable! That means I will be charged. I may have to pay a fine or go to prison.

It is also a criminal offence if I give false information in order to get a residence permit!

4. **If I state something incorrectly or if I don't state everything, I may not get a residence title! It is also possible that the authorities will not renew my residence title.** This can also happen if I do not adhere to points 1 to 4 of this final declaration.

5. **Reporting obligations:**

- I have to announce immediately if the purpose of residence changes. I may only do what is part of my purpose of residence.
- I have to hand in Austrian documents that are not or no longer valid to the authorities.
- I have to report to the authority immediately if someone has stolen my documents, if I have lost them or if the documents have become broken. I also have to report immediately if my data changes. For example, if I get married and change my name.
- If my family circumstances change, I have to report this to the authorities after 1 month at the latest. For example, if I get married or divorced.

I commit an administrative offence if I do not comply with what is written in point 5. If I commit an **administrative offence**, I have to pay a **fine of 50 euros to 250 euros**.
